What are we talking about?

- The IT readiness survey takes a look at how wellprepared IP firms are to take on the digitalization of their work flows.
- Among others the survey addresses questions about the budget reserved to IT, the implementation of automated workflows, communication means with foreign counsel, etc but also some prospective thinking re. business from a techno. point of view.
- Survey opened on March 28 and closed on July 1, 2019.

• 5-6% 20%


• 3 to 5% 27%



Q.3 Do you consider yourself as a paperless firm?






Q.6 Can your clients access their portfolio via your website?


Q.7 Is it a client requirement?

Q.8 Does your IP Office support electronic filing?




Q.9 If so, are you using electronic filing?



Q.10 If not, why not?


- IP Office does not provide such possibility

Q.11 Does your IP office allow "scraping" the database regarding the matters for which you are agent of record, in order to automatically be advised of actions in the file?








Q.14 Are you using cloud services?

Q.15 If so, what services are hosted?




Q.17 What issues did you encounter when rolling out cloud services?


Q.24 If so, what is the biggest challenge in successfully implementing these tools?

- AI for searching and drafting, etc: 47% of the respondents
- Automated workflows: 18%
 - for docketing and reporting
 - for communications with IP offices, clients, internally
 - for internal processes and controls
- 7% don't know
- The human factor: 1 response

Q.27 What do you see as the biggest advantage to doing so?

•	Increased efficiency (in terms of organization, etc.):	52%
•	Safety / reliability:	30%
•	Cost-saving:	25%
•	Time-saving:	19%
•	Quality improvement:	6%

Q.28 What is the biggest disadvantage?

•	Cost:	34%

•	Loss of control, enhanced dependency on technology:	24%
•	Resistance to change (attorneys and staff)	20%

Q.29 From a technological point of view, where does the biggest threat to your current business model lie?

- Face the competition (e-filing providers, start-ups deploying services: 27%
- Commoditization: 13%
- Small and medium-sized firms afraid of being too small to invest in these technologies and develop at the same time to compete: 10%
- Training staff attitudes: 8%
- Security (hacking, malware, ransomware): 8%

Q.30 From a technological point of view, where does the greatest opportunity for growth lie?

- Efficiency of AI based administrative workflows and related cost reduction: 42%
- Security: 5%

Q.31 What, if any, role could FICPI play to help you regarding implementation, management, or training of IT services?

- Sharing experiences among professionals, success stories and challenges: 30%
- Awareness: 30%
 - update members about new technologies 'state of the art'
 - inform on the technologies available in our business field without playing a vendor's role
 - if enough members show interest in a system, play the offer/demand and have the purchase cost down (for SMEs)
- Provide standards (AFNOR/ISO): 12%
- Provide best practice guidelines: 12%
- Suggesting proper IA system for firms: 9%
- Training: 3%
- Setting up a committee with a deeper insight in these matters (!)
